Authorizing Bond Ordinances-Various Purposes as follows:

A – Building Alterations Ordinance - 10 years (\$95,000)

B – Acquisition of Machinery and Apparatus Ordinance & Surveys - 15 years (\$751,500) (subject to permissive referendum)

C – Improvements to Parks Ordinance - 15 years (\$250,000)

D – Sewer Improvements Ordinance - 30 years (\$5,149,152)

E – Water Improvements Ordinance - 40 years (\$1,823,000)

Dear Susan:

As requested, attached please find the following:

- (1) Five Extracts (A-E) from minutes of a meeting of the City Council of the City adopting serial bond ordinances authorizing the issuance of serial bonds of the City to finance an aggregate amount of \$8,068,652 for the costs of various public purposes in and for the City.
- (2) Public Notice (B only);
- (3) Certificate of No Protest (B only); and
- (4) Estoppel Notices

Upon the adoption by at least two-thirds of the full voting strength of the City Council of the City of the bond ordinances (documents (1), above), the extract pages and the certificates of the City Clerk therefor should be completed and sealed in appropriate form and one such copy thereof returned to our office for our transcript file.

With respect to the resolution labeled B for the acquisition of machinery and apparatus and surveys, within ten (10) days of adoption, the Public Notice (documents (2), above) must be published as required by the City Charter and, upon receipt thereof, the original affidavit of publication of the Public Notices should then be forwarded to my attention.

After forty-five (45) days shall have elapsed following the adoption the bond ordinance, if no petition shall have been filed with the City Clerk protesting the adoption, the Certificate of No Protest (documents (3), above) for the bond ordinance should be completed and executed, and the bond ordinance, together with the estoppel notice (document (4), above), should be published in the local newspaper. Upon receipt and completion thereof, please furnish to us the original affidavit of such publication, along with certified copy of the Certificate of No Protest.

The bond resolutions A, C D and E need only to be published with the estoppel respective notices immediately after due adoption by the City Council. We should receive a certified copy of these bond resolutions in extract form and the original affidavits of publication of the bond resolution and the estoppel notice.

We have also included an environmental compliance resolution which should be adopted at the same meeting as the bond ordinances as the first order of business. There is no requirement to publish the environmental compliance resolution in the City paper.
