MYTHS

- Juveniles who set fires are pyromaniacs or arsonists.
- Juveniles who play with fire, or set fires, do so because of some "urge" or "obsession" with fire.
- Older children light more dangerous and deadly fires.
- Firesetting is a difficult behavior to treat.
- Playing with fire is a part of normal developmental phase for young children.
- Giving youth information about fire will encourage them to want to play with fire.

FACTS

Annually, fireplay causes an average of:

- 80 civilian deaths
- 860 injuries
- \$265 million in property damage

Lighters or matches caused 83% of civilian deaths.

Vast majority of structure fires (over 80%) caused by males

• 43% of those caused by children under the age of 6 years old.

OUR MISSION:



Sometimes, children start fires out of curiosity. Sometimes, it's more than that.


J-FIRE Intervention Specialists are trained and capable of assessing your child to determine the severity of the risk and to determine what is motivating your child to start fires.



Fire is dangerous, and can quickly get out of control for an adult, let alone a child. Children often overestimate their ability to control fire. A single match can destroy many things: A house, a life, a family.

J-FIRE Intervention Specialists help assess why your child is starting fires, and have the training and insight needed to help you intervene to keep your child and your family safe.
