To the Beacon City Council:

My name is Atticus Lanigan and I am General Manager and co-Owner of Zero to Go, LLC. We are a zero waste management company based in Beacon and we currently run a compost pick-up/drop-off program here. We manage the waste at the Beacon Farmer's Market, accept customers' household compost, and educate market-goers on what is recyclable and compostable. I am writing to show our support for the 2017 *re*-location of the Beacon Farmer's Market.

Although we enjoyed substantial exposure at the previous, riverfront location, we have seen a great increase in the amount of foot traffic at the new one. Specifically, the location of the market on Veteran's Place is more likely to draw out City of Beacon residents due to its increased accessibility to its neighborhoods via foot and bike travel. And, although we are always happy to educate tourists and people from neighboring towns, our target market is people living in Beacon. It is safe to say that our drop-off service and, as a result, our pick-up service, has grown dramatically from said increased exposure to Beacon residents. For this reason, we absolutely support the market being at the Central Main location, bridging the east and west ends of town.

In addition to my work with Zero to Go, I also held the position of Planner for the Orange County Planning Department from 2006 to 2011. While there I worked closely with the county's 19 farmer's markets, which ranged in style, scope and context. One of the main considerations in that work was how to promote the markets while maintaining (and not impeding) and possibly increasing foot traffic, with conflict between businesses in the Central Business Districts (CBDs) and farm market vendors often the top priority. More often than not, businesses found that having a weekly farmer's market was actually an enhancement to the vibrancy of their business districts.

As farmer's markets have increased in number across the country in the last 20 years, there has been a lot of research regarding how they affect CBDs. In an article on how markets enhance the business of nearby bookstores (Button. 2016. *Farmer's Markets and Main Street Businesses: Natural Partners*. American Bookseller's

Association. www.bookweb.org), author Liz Button states, "While farmer's markets have the ability to unite small businesses in mutually profitable partnerships via formal selling agreements, a market's mere proximity to a store can oftentimes increase foot traffic and sales significantly."

Another consideration for Orange County markets was how they improved tourism for those CBDs that counted on out-of-town visitors to maintain a healthy economy. This is definitely a consideration in Beacon, which is one of the top destination towns in the region. One important principle in the promotion of tourist amenities is the element of the unexpected. That is, visitors not only seek out specific things to do, they also enjoy the ability to stroll and come upon activities that they were not expecting to encounter. This unanticipated fun is what visitors often talk about when they recommend destinations to friends and acquaintances. In the case of the Beacon Farmer's Market, people coming for a show at the Towne Crier Cafe, a well-known tourist draw, are often delighted that they can also buy local fare and enjoy music and conversation beforehand at the market (and then check out the flea market!). Likewise, people drawn to the Farmer's Market can take in an unexpected show at the Towne Crier, have a sit-down meal and even a cocktail. Since we have such a variety of people showing up on Sundays in Beacon, there is no doubt that offering a *variety* of things to do and buy in our CBD is a strength, not a weakness. In other words, two great tourist draws are better than one and businesses near Central Main Street can only benefit from the multitude of activities therein.

Once again, we support the Veteran's Place location of the Beacon Farmer's Market and ask that the City lend the same support to this great amenity.

Hi Sara -

I'm sorry to hear that you have had such a response to the market. I'd be happy to talk to you about it, but I think I can sum up my experiences here via email.

Overall I continue to be supportive of the market being here on Main Street. I definitely felt the market brought me business. Of course I have a regular customer base already and I know I saw them on Sundays (whereas previously I may not have) and they indicated they stopped here for a coffee / pastry / grocery item prior or after heading to the market. So there was definite feedback that way which I can point to as a positive for us.

In a less scientific way I can say that the feedback from customers was initially mixed but then turned positive. And i know that tourists definitely enjoyed it. I think that Main Street is really a destination now (as opposed to when I moved to the area years ago) and I think it makes sense to have these destinations on Main Street (from the farmer's market, to the flea market.) In terms of the customer feedback, at the beginning I remember hearing from a few regular customers that they felt out of sorts with parking, kids running toward Main Street, etc. But I think they settled down. I certainly continued to see them on Sundays coming to / from the market so I think it was just initial reaction as happens with anything new.

Our principal mission and goal here as a food business is to share good clean food with the public, so from that perspective I am 100% supportive of anything that leads to more people enjoying good local food. At the beginning I was slightly concerned with whether or not there would be food vendors / carts / takeout food / coffee service, etc. But honestly we are busy and there is good coffee and food all over the place. In that regard I just keep my head down and doing what we do and I don't worry about what others are doing. At the beginning it is easy to get caught up with feeling worried about competition, but competition is a good thing and i think it helps to keep us on our toes, which is very important to me.

It is definitely hard to have the influx of tourists in the summer, people parading in and out using the bathroom, pretending to shop in order to use the facilities, asking for water bottle refills and all the other side issues that come with tourists, but honestly that is just what we face having a business in a tourist town. I just try to remember that for every person that comes in and to whom I am friendly and hospitable, they might decide to come back the next day for a meal or decide to sit down and buy something even if they weren't going to initially. A smile and being accommodating to tourists is not always easy but it is the way we want to do business. And who among us hasn't been a tourist at some point just needing to go to the bathroom or just need a drink of water for their kid?

Anyhow, that's my two cents. I am in support of the market staying here and I'm happy to discuss this further i needed and you are welcome to use anything stated above in terms of your defense of it remaining here. Let me know how else I can help. Stacey

Dear Beacon City Council:

I am writing on behalf of the Common Ground Farmers' Market and its vital location in the middle of Beacon's Main Street. It will be of no surprise that someone like me, a culinary instructor and cookbook author, is brimming with glowing and positive accolades for this recent move to town, which brings the face of local food and handmade products into the center of our vibrant town, where it belongs.

While I made my way down to the waterfront in years passed to shop the Sunday market, there is a marked difference between getting in a car to go to one destination and strolling into to town to see my fellow neighbors and friends, so many of whom walk to the summer market now. There is no other commerce down at the docks, but there is so much up in town; it would make sense that nearby business owners would benefit from the extra foot traffic as opposed to being put off by lively music and general positive nature that a farmer's market provides to a small town like Beacon. I understand that there is issue with the fact that the market sells more than vegetables, and I would argue that farmers markets nationwide always sell more than just vegetables; it is built on supporting "local" products, most of which are edible, but certainly not all. It is part of a movement to support local commerce of all kinds. If a market just sold vegetables, it could not sustain itself with the competition between every other farm stand, which sells practically the same produce. That is the nature of local foods. Only certain things grow at certain times in certain area. Markets need to diversify to survive and support the farmers they draw in.

It would be a terrible shame if this farmers market could not continue to thrive in the middle of Beacon, where it belongs. We entertain droves of out-of-town visitors every weekend, and what better way to draw them up deeper into town (farther in than DIA or the west side of Main Street where they linger on foot), so they can see the magic of this town's community engagement and its love and support of local initiatives. Parking is a nightmare in town on weekends for those of us who live here. How wonderful is it that we have something to do right in the middle of town that doesn't require so many of us to get into a car.

I have been a vendor at the farmers' market since about 2008. At that time, an opportunity arose to start a winter market, at the Beacon Sloop Club. I was invited to become a vendor, and currently I do the outdoor market with my handmade pottery on a bi-weekly basis. I always make a point to chat with customers. Some are new to the area, and love the idea of knowing who is producing their food. Many people are able to walk to the location, and most also shop at other local businesses. (I try to make most of my weekly food purchases on Main St. myself).

Some of the vendors at the market also maintain brick & mortar shops on Main St. I sell my pottery at a number of local shops-I always make a point of mentioning these-I think we all need to support one another!

Several Main St. business owners have told me that Sunday traffic to their shops actually increased when the market moved to Main St. There are some instances, in which Main St. businesses have found new supply sources at the market, such as honey, eggs, and meat.

The Beacon Farmers' Market has grown over the years, to become a vital part of the Main St. scene-at least for a few short hours every Sunday.

As a SNAP benefit recipient I have personally benefited from the Beacon Farmer's Market being located at veteran's place, as it is closer to my home. When the Farmer's market was located at the train station it was very difficult for myself as well as my family to get to. Due to its new location visiting the Flea market as well as the Farmer's Market on Sundays is now a Spring/ Summer tradition in my home. My family and I are able to walk to the market and make a day out of it, often visiting local businesses after we leave the market. The inviting music makes my family and I feel comfortable to lingering at the Farmer's Market causing us to spend more time and money there thus supporting more local farms and businesses. The Beacon Farmer's Market does an incredible job making healthy food more accessible to families in my circumstance. I live below the poverty line and receive government assistance making my food dollar very limited; however the Beacon Farmer's Market has several incentive programs which double my spending power. This is crucial for my family as we live on a very fixed income. I fear that if the Farmer's Market moves back down to the river front I will no longer have access to fresh food in the Spring and Summer that my family has grown so accustomed too. The rising cost of living in the City of Beacon has made me have to spend less and less of my pay check on food, forcing me to rely even more heavily than ever on the food stamps I receive. Losing access to the Farmer's Market would be detrimental to the overall health of my family.
