The Pavilion was previously located in a residential zoning district that did not allow its use to be legal as a restaurant seating area but has been included in the CMS district after a recent restructuring of the City Zoning Map. The old zoning map bisected the parcel with a residential zone to the rear and commercial along Main Street, the rezoning included the entire parcel in the same zoning district (CMS). The use is now permitted for the structure after the zoning change. The new outdoor seating would use string lighting to mark walkways and light under the pavilion. Outdoor speakers are also mounted under the Pavilion.

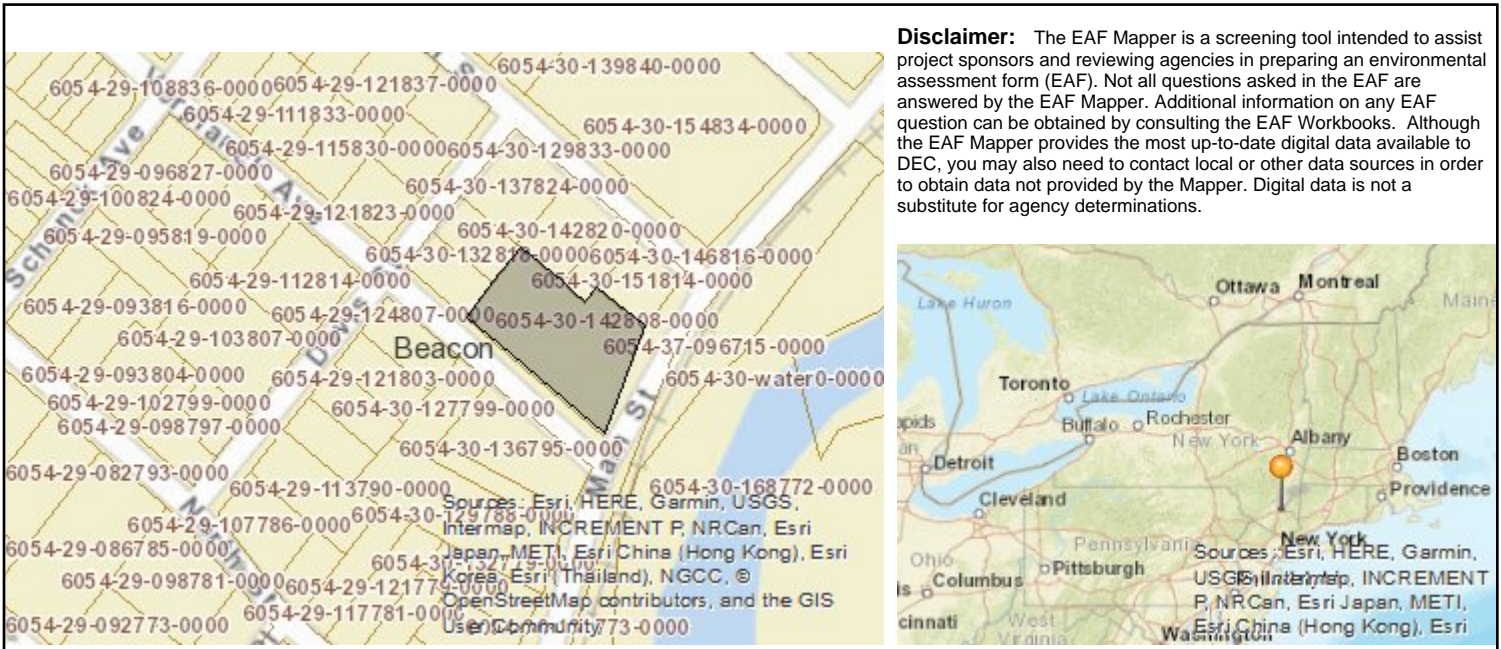
